Last week, the High Court of Australia (HC) delivered judgment in the case of *B v BC*. In this case, a woman had failed to meet the burden of proving that her partner's best friend had 'sexual intercourse' with her. The HC dismissed her claim (and with it her life) because the matter had not been clearly decided by the trial court. In the trial proceedings, the woman had alleged that the man's friend had 'had sex' with her in a 'public place'. The trial judge had found that she had not met her burden of proof and, therefore, he had dismissed the claim. The HC has now come to the same conclusion. This means that the woman's life is now spent. It also means that the High Court has rendered its judgment without affording the woman the opportunity to appeal to the full bench of the bench of the bench of the High Court. The High Court, like all other courts, can determine which course of action is appropriate in the case of factual ambiguity. In this case, there was considerable ambiguity. The trial court found that the term 'public place' required the state of mind of the person being addressed. In the trial court, the plaintiff had not asked the question (at the time) 'Would you now agree with me that you were in a public place when the alleged sexual activity occurred?'. A similar situation arose in the early days of the English Court of Chancery. There, the chancery judge found a man guilty of abduction 82138339dc
