Other than this, the only issue in the case is whether plaintiff's execution of the assignment contract was fraudulent. In the absence of fraud the matter is at an end. (b) The court finds that since plaintiff was discharged, the policy issued to defendant has been cancelled. Plaintiff has alleged, and defendant has denied, that defendant's property and office were damaged as a result of plaintiff's conduct. In the main the court has found against plaintiff on the issue of liability for such damage. These matters, however, must be retried on the issue of damages. The plaintiff, while reserving the right to the contrary, has agreed to abide by any ruling made by the court on the question of punitive damages. Since the court has found no such damages to have been suffered, the plaintiff is not entitled to punitive damages, and the issue raised by the seventh counterclaim must be set for trial. (c) Defendant has set forth the pleadings filed by the parties in the other district court in the state of Florida. The trial court found that no Florida statute forbade the institution of a suit against a corporation in the United States District Court for the Northern District of Illinois, and that the case was not removable. Defendant seeks to have this court certify that there is no basis in fact or law for the finding that a suit cannot be brought in this court. Defendant relies on 28 U.S.C. § 1441(a), which states in pertinent part that any civil action brought in the district court against the defendants may be removed from the state court to the federal district court for the district where the claim has been originally filed. The plaintiff attacks defendant's reliance on 28 U.S.C. § 1441(a). He alleges that under Illinois law a suit can be filed in the United States District Court only after the person or corporation to be sued has been served with process. 28 U.S.C. § 1441(a) does not give defendant authority to remove *830 a case to the federal court where
